#### 1. RESOLUTION 1 – REMUNERATION REPORT

To consider and, if thought fit, to pass, with or without amendment, the following resolution as a **non-binding ordinary resolution**:

*“That, for the purposes of the Corporations Act 2001 and for all other purposes, Shareholders approve and adopt the remuneration report as contained in the Company’s annual financial report for the year ended 30 June 2020.”*

Note: The vote on this Resolution is advisory only and does not bind the Directors or the Company. Shareholders are encouraged to read the Explanatory Statement regarding the consequences of voting on this Resolution.

**Voting Prohibition Statement:** A vote on this Resolution must not be cast (in any capacity) by or on behalf of either of the following persons:

- (a) a member of the Key Management Personnel, details of whose remuneration are included in the Remuneration Report; or

## EXPLANATORY STATEMENT

---

This Explanatory Statement has been prepared to provide information which the Directors believe to be material to Shareholders in deciding whether or not to pass the Resolutions.

---

### 1. BACKGROUND TO RESOLUTIONS

#### 1.1 Resolutions 5, 6 and 7 - Placement announced 12 August 2020

As announced to ASX on 12 August 2020, the Company completed a total capital raising of 187,680,000 fully paid ordinary shares to sophisticated and professional investors at \$0.0125 per Share to raise \$2,346,000 (before costs) (**Placement**). Successful participants to the Placement became eligible to receive one (1) free attaching Option for each Share subscribed for and issued under the Placement, exercisable at \$0.015 per Option at any time up to 30 June 2021.

The Shares were issued on 17 August 2020. Of the total issued of 187,680,000, 100,000,000 were issued under the Company's Listing Rule 7.1 placement capacity and had already been ratified at the General Meeting held on 16 July 2020. Of the remaining 87,680,000, 52,603,931 Shares issued pursuant to the Company's Listing Rule 7.1 placement capacity and 35,076,069 Shares issued pursuant to the Company's Listing Rule 7.1A placement capacity. The Company is seeking ratification of the issue of the Shares the subject of the Placement pursuant to Resolutions 5 and 6.

Of the total options to be issued pursuant to the Placement, being 187,680,000, 93,839,995 options were issued on 17 August 2020 under the Company's Listing Rule 7.1 placement capacity and had already been ratified at the General Meeting held on 16 July 2020. The issue of the remaining Options, being 93,840,005, is subject to the Company obtaining the Shareholder approval the subject of Resolution 7.

The Company, subject to, and conditional upon, complying with all ASX Listing Rule requirements, intends to seek ASX quotation of the Options. The Options will only be quoted where all the requirements of ASX Listing Rule 2.5 condition 6 are met, including the requisite number of holders.

#### 1.2 Resolution 8 - Issue of Options for acting as Broker

The Company proposes to issue up to 26,000,000 Options to Peak Asset Management Pty Ltd (ACN 618 737 009) (**Peak Asset Management**) (or its nominee/s) as part consideration for Peak Asset Management acting as Corporate Adviser and Lead Manager to the Placement announced on ASX on 12 August 2020.

Pursuant to an Engagement Letter dated 10 August 2020 between the Company and Peak Asset Management, subject to receipt of Shareholder approval, the Company has agreed to issue Peak Asset Management or its nominee with 26,000,000 Options for the corporate advisory and lead manager services.

The Options to be issued to Peak Asset Management are the subject of Resolution 8.

The Company, subject to, and conditional upon, complying with all ASX Listing Rule requirements, intends to seek ASX quotation of the Options to be issued to Peak Asset Management. The Options will only be quoted where all the



requirements of ASX Listing Rule 2.5 condition 6 are met, including the requisite number of holders.

### 1.3 Resolution 9 - Approval for future issue of Shares and Options

Resolution 9 seeks Shareholder approval for the issue of up to 100,000,000 Shares and up to 100,000,000 free-attaching Options. Further information in relation to this Resolution is outlined in Section 10.

### 1.4 Resolution 10 - Approval for future issue of Options

Resolution 10 seeks Shareholder approval for the issue of up to 80,000,000 Options. Further information in relation to this Resolution is outlined in Section 11.

### 1.5 Pro forma capital structure

The proposed capital structure of the Company following completion of the Acquisition and issues of all securities contemplated by this Notice, assuming no Options are exercised prior to the date of this Notice, is set out below:

## **2. FINANCIAL STATEMENTS AND REPORT**

In accordance with the Constitution, the business of the Meeting will include receipt and consideration of the annual financial report of the Company for the financial year ended 30 June 2020 together with the declaration of the directors, the directors' report, the Remuneration Report and the auditor's report.

The Company will not provide a hard copy of the Company's annual financial report to Shareholders unless specifically requested to do so. The Company's annual financial report is available on its website at [www.goldendeeps.com](http://www.goldendeeps.com)

## **3. RESOLUTION 1 – REMUNERATION REPORT**

### **3.1 General**

The Corporations Act 2001 requires that at a listed company's annual general meeting, a resolution that the remuneration report be adopted must be put to the shareholders. However, such a resolution is advisory only and does not bind the company or the directors of the company.

The remuneration report sets out the company's remuneration arrangements for the directors and senior management of the company. The remuneration report is part of the directors' report contained in the annual financial report of the company for a financial year.

The chair of the meeting must allow a reasonable opportunity for its shareholders to ask questions about or make comments on the remuneration report at the annual general meeting.

### **3.2 Voting consequences**

A company is required to put to its shareholders a resolution proposing the calling of another meeting of shareholders to consider the appointment of directors of the company (Spill Resolution) if, at consecutive annual general meetings, at least 25% of the votes cast on a remuneration report resolution are voted against adoption of the remuneration report and at the first of those annual general meetings a Spill Resolution was not put to vote. If required, the Spill Resolution must be put to vote at the second of those annual general meetings.

If more than 50% of votes cast are in favour of the Spill Resolution, the company must convene a shareholder meeting (Spill Meeting) within 90 days of the second annual general meeting.

All of the directors of the company who were in office when the directors' report (as included in the company's annual financial report for the most recent financial year) was approved, other than the managing director of the company, will cease to hold office immediately before the end of the Spill Meeting but may stand for re-election at the Spill Meeting.

Following the Spill Meeting those persons whose election or re-election as directors of the company is approved will be the directors of the company.

### **3.3 Previous voting results**

At the Company's previous annual general meeting the votes cast against the remuneration report considered at that annual general meeting were less than 25%. Accordingly, the Spill Resolution is not relevant for this Annual General Meeting.

---

## **4. RESOLUTION 2 – RE-ELECTION OF A DIRECTOR – MR MICHAEL SCIVOLO**

### **4.1 General**

ASX Listing Rule 14.4 provides that, other than a managing director, a director of an entity must not hold office (without re-election) past the third AGM following the director's appointment or 3 years, whichever is the longer. However, where there is more than one managing director, only one is entitled not to be subject to re-election.

The Constitution sets out the requirements for determining which Directors are to retire by rotation at an annual general meeting.

Mr Michael Scivolo, who has served as a director since 23 July 2012 and was last re-elected on 16 November 2017, retires by rotation and seeks re-election.

### **4.2 Qualifications and other material directorships**

Mr Scivolo has extensive experience in the fields of accounting and taxation in both corporate and non-corporate entities. He was a Director of Blaze International Limited until 4 December 2015, K2Fly Ltd (formerly Power Resources Limited) until 17 November 2016 and Covata Ltd (formerly Prime Minerals Limited) until 29 October 2014. He is currently a Director of Metals Australia Ltd, Sabre Resources Ltd and Blina Minerals NL.

### **4.3 Independence**

If elected, the board considers Mr Michael Scivolo will be an independent director.

### **4.4 Board recommendation**

The Board supports the re-election of Mr Michael Scivolo and recommends that Shareholders vote in favour of Resolution 2.

---

## **5. RESOLUTION 3 – ELECTION OF DIRECTOR – MR SCOTT MATHEWSON**

### **5.1 General**

The Constitution allows the Directors to appoint at any time a person to be a Director either to fill a casual vacancy or as an addition to the existing Directors, but only where the total number of Directors does not at any time exceed the maximum number specified by the Constitution.

Pursuant to the Constitution and ASX Listing Rule 14.4, any Director so appointed holds office only until the next Annual General Meeting and is then eligible for election by Shareholders but shall not be taken into account in determining the Directors who are to retire by rotation (if any) at that meeting.

Mr Mathewson, having been appointed by other Directors on 15 April 2020 in accordance with the Constitution, will retire in accordance with the Constitution and ASX Listing Rule 14.4 and being eligible, seeks election from Shareholders.

## **5.2 Qualifications and other material directorships**

Mr Mathewson has over 25 years of experience in senior operational, technical and leadership roles in the metals, mining and mineral processing sectors with a focus on operations, mining, process engineering and business improvement. He has a passion for safety and fostering a caring culture across the business.

Prior to joining Golden Deeps, Mr Mathewson was the EGM of Global Mining and Production for an international mineral sands producer where he was responsible for all mining and production operations and the development of future growth and expansion opportunities. Prior to this, he was Technical Director within the Corporate Finance sector responsible for raising capital for new mining operations in Australia and Internationally. Across his career, Scott has also held senior positions with Rio Tinto, Alcoa World Alumina and Atlantic Vanadium.

Mr Mathewson holds a Bachelor of Chemical Engineering from Curtin University and a MBA from the University of Southern Queensland where he majored in OHS and Corporate Finance. He also holds an Unrestricted WA Quarry Manager Certification.

## **5.3 Independence**

Mr Mathewson has no interests, positions, association or relationship that might influence, or reasonably be perceived to influence, in a material respect his capacity to bring an independent judgement to bear on issues before the Board and to act in the best interests of the entity and its security holders generally.

If elected, the board considers Mr Scott Mathewson will be an independent director.

## **5.4 Board recommendation**

The Board supports the re-election of Mr Mathewson and recommends that Shareholders vote in favour of Resolution 3.

---

## **6. RESOLUTION 4 – APPROVAL OF 10% PLACEMENT CAPACITY**

### **6.1 General**

ASX Listing Rule 7.1A provides that an Eligible Entity (as defined below) may seek shareholder approval by special resolution passed at an annual general meeting to have the capacity to issue up to that number of Equity Securities (as defined below) equal to 10% of its issued capital (10% Placement Capacity) without using that company's existing 15% annual placement capacity granted under ASX Listing Rule 7.1.

An Eligible Entity is one that, as at the date of the relevant annual general meeting:

- (a) is not included in the S&P/ASX 300 Index; and

- (b) has a maximum market capitalisation (excluding restricted securities and securities quoted on a deferred settlement basis) of \$300,000,000.

As at the date of this Notice, the Company is an Eligible Entity as it is not included in the S&P/ASX 300 Index and has a current market capitalisation of \$8,615,051 (based on the number of Shares on issue and the closing price of Shares on the ASX on 15 September 2020).

An Equity Security is a share, a unit in a trust, a right to a share or unit in a trust or option, an option over an issued or unissued security, a convertible security, or, any security that ASX decides to classify as an equity security.

Any Equity Securities issued under the 10% Placement Capacity must be in the same class as an existing class of quoted Equity Securities.

As at the date of this Notice, the Company currently has two classes of quoted Equity Securities on issue, being the Shares (ASX Code: GED) and Options (ASX Code: GEDO).

If Shareholders approve Resolution 4, the number of Equity Securities the Company may issue under the 10% Placement Capacity will be determined in accordance with the formula prescribed in ASX Listing Rule 7.1A.2.

Resolution 4 is a special resolution. Accordingly, at least 75% of votes cast by Shareholders present and eligible to vote at the Meeting must be in favour of Resolution 4 for it to be passed.

## **6.2 Technical information required by ASX Listing Rule 7.1A**

Pursuant to and in accordance with ASX Listing Rule 7.3A, the information below is provided in relation to this Resolution 4:

### **(a) Minimum Price**

The minimum price at which the Equity Securities may be issued is 75% of the volume weighted average price of Equity Securities in that class, calculated over the 15 ASX trading days on which trades in that class were recorded immediately before:

- (i) the date on which the price at which the Equity Securities are to be issued is agreed; or
- (ii) if the Equity Securities are not issued within 5 ASX trading days of the date in Section 5.2(a)(i), the date on which the Equity Securities are issued.

### **(b) Date of Issue**

The Equity Securities may be issued under the 10% Placement Capacity commencing on the date of the Meeting and expiring on the first to occur of the following:

- (i) 12 months after the date of this Meeting; and
- (ii) the date of approval by Shareholders of any transaction under ASX Listing Rules 11.1.2 (a significant change to the nature or scale of the Company's activities) or 11.2 (disposal of the Company's main undertaking) (after which date, an approval under Listing Rule 7.1A ceases to be valid).

**(10% Placement Capacity Period).**

**(c) Risk of voting dilution**

Any issue of Equity Securities under the 10% Placement Capacity will dilute the interests of Shareholders who do not receive any Shares under the issue.

If Resolution 4 is approved by Shareholders and the Company issues the maximum number of Equity Securities available under the 10% Placement Capacity, the economic and voting dilution of existing Shares would be as shown in the table below.

The table below shows the dilution of existing Shareholders calculated in accordance with the formula outlined in ASX Listing Rule 7.1A(2), on the basis of the market price of Shares and the number of Equity Securities on issue as at 15 September 2020.

The table also shows the voting dilution impact where the number of Shares on issue (Variable A in the formula) changes and the economic dilution where there are changes in the issue price of Shares issued under the 10% Placement Capacity.

Shareholders should note that there is a risk that:

**(d) Purpose of Issue under 10% Placement Capacity**

The Company may issue Equity Securities under the 10% Placement Capacity for the following purpose:

- (i) as cash consideration in which case the Company intends to use funds raised for the acquisition of additional natural resource exploration projects (including expenses associated with such an acquisition) and advancement of the Company's Havilah Gold Project and Tuckers Hill Gold Project which are both located in New South Wales, the Abenab vanadium project located in Namibia, including advancing a feasibility study, ongoing exploration and pre-production costs, or for exploration expenditure on any future assets acquired by the Company and general working capital.

The Company will comply with the disclosure obligations under Listing Rules 7.1A(4) and 3.10.5A upon issue of any Equity Securities.

**(e) Allocation policy under the 10% Placement Capacity**

The recipients of the Equity Securities to be issued under the 10% Placement Capacity have not yet been determined. However, the recipients of Equity Securities could consist of current Shareholders or new investors (or both), none of whom will be related parties of the Company.

The Company will determine the recipients at the time of the issue under the 10% Placement Capacity, having regard to the following factors:

- (i) the purpose of the issue;
- (ii) alternative methods for raising funds available to the Company at that time, including, but not limited to, an entitlement issue or other offer where existing Shareholders may participate;
- (iii) the effect of the issue of the Equity Securities on the control of the Company;
- (iv) the circumstances of the Company, including, but not limited to, the financial position and solvency of the Company;
- (v) prevailing market conditions; and
- (vi) advice from corporate, financial and broking advisers (if applicable).

Further, if the Company is successful in acquiring new resources, assets or investments, it is likely that the recipients under the 10% Placement Capacity will be vendors of the new resources, assets or investments.



**(f) Previous approval under ASX Listing Rule 7.1A**

The Company previously obtained approval from its Shareholders pursuant to ASX Listing Rule 7.1A at its annual general meeting held on 29 November 2019 (**Previous Approval**).

The Company has issued 84,274,702 Shares pursuant to the Previous Approval.

During the 12 month period preceding the date of the Meeting, being on and from 16 September 2019, the Company also issued a further 217,788,208 Shares and 193,992,135 Options which represents approximately 143% of the total diluted number of Equity Securities on issue in the Company on 29 November 2019, which was 286,223,944

Further details of the issues of Equity Securities by the Company during the 12-month period preceding the date of the Meeting are set out in Schedule 2.

**(g) Compliance with ASX Listing Rules 7.1A.4 and 3.10.5A**

When the Company issues Equity Securities pursuant to the 10% Placement Capacity, it must give to ASX:

- (i) a list of the recipients of the Equity Securities and the number of Equity Securities issued to each (not for release to the market), in accordance with Listing Rule 7.1A.4; and
- (ii) the information required by Listing Rule 3.10.5A for release to the market.

**6.3 Voting Exclusion**

A voting exclusion statement is included in this Notice. As at the date of this Notice, the Company has not invited any existing Shareholder to participate in an issue of Equity Securities under ASX Listing Rule 7.1A. Therefore, no existing Shareholders will be excluded from voting on Resolution 4.

---

**7. RESOLUTIONS 5 AND 6 – RATIFICATION OF PRIOR ISSUE – PLACEMENT SHARES (LR 7.1 AND LR 7.1A)**

**7.1 General**

On 17 August 2020, the Company issued 87,680,000 Shares at an issue price of \$0.0125 per Share to raise \$1,096,000 (before costs of the issue) (**Placement Shares**).

52,603,931 Shares were issued pursuant to the Company's Listing Rule 7.1 placement capacity (being the subject of Resolution 5) and 35,076,069 Shares were issued pursuant to the Company's Listing Rule 7.1A placement capacity (being the subject of Resolution 6). The Company's Listing Rule 7.1A mandate was approved at its Annual General Meeting held on 29 November 2019.

The Company engaged the services of Peak Asset Management Pty Ltd (ACN 156 168 366), a corporate authorised representative of Equity Underwriters Pty Ltd (AFSL 244040) to manage the issue of the Placement Shares. The Company has paid Peak Asset Management Pty Ltd a commission of \$65,760 (being, 6% of the amount raised under the issue of the Placement Shares allocated to Peak Asset Management Pty Ltd) plus GST. Peak Asset Management Pty Ltd will also,

subject to receiving shareholder approval via Resolution 8, receive 26,000,000 options with an exercise price of \$0.015 and expiry date of 30 June 2021 as a fee.

## **7.2 Listing Rules 7.1 and 7.1A**

Broadly speaking, and subject to a number of exceptions, Listing Rule 7.1 limits the amount of equity securities that a listed company can issue without the approval of its shareholders over any 12 month period to 15% of the fully paid ordinary securities it had on issue at the start of that 12 month period.

Under Listing Rule 7.1A however, an eligible entity can seek approval from its members, by way of a special resolution passed at its annual general meeting, to increase this 15% limit by an extra 10% to 25%.

The Company obtained approval to increase its limit to 25% at the annual general meeting held on 29 November 2019.

The issue of the Placement Shares does not fit within any of these exceptions and, as it has not yet been approved by Shareholders, it effectively uses up part of the 25% limit in Listing Rules 7.1 and 7.1A, reducing the Company's capacity to issue further equity securities without Shareholder approval under Listing Rule 7.1 and 7.1A for the 12 month period following the date of issue of the Placement Shares.

## **7.3 Listing Rule 7.4**

Listing Rule 7.4 allows the shareholders of a listed company to approve an issue of equity securities after it has been made or agreed to be made. If they do, the issue is taken to have been approved under Listing Rule 7.1 and so does not reduce the company's capacity to issue further equity securities without shareholder approval under that rule.

The Company wishes to retain as much flexibility as possible to issue additional equity securities in the future without having to obtain Shareholder approval for such issues under Listing Rule 7.1. Accordingly, the Company is seeking Shareholder ratification pursuant to Listing Rule 7.4 for the issue of the Placement Shares.

Resolutions 5 and 6 seek Shareholder ratification pursuant to Listing Rule 7.4 for the issue of the Placement Shares.

## **7.4 Technical information required by ASX Listing Rule 14.1A**

If Resolutions 5 and 6 are passed, the Placement Shares will be excluded in calculating the Company's combined 25% limit in Listing Rules 7.1 and 7.1A, effectively increasing the number of equity securities the Company can issue without Shareholder approval over the 12 month period following the date of issue of the Placement Shares.

If Resolutions 5 and 6 are not passed, the Placement Shares will be included in calculating the Company's combined 25% limit in Listing Rules 7.1 and 7.1A, effectively decreasing the number of equity securities the Company can issue without Shareholder approval over the 12 month period following the date of issue of the Placement Shares.

## **7.5 Technical information required by ASX Listing Rule 7.5**

Pursuant to and in accordance with ASX Listing Rule 7.5, the following information is provided in relation to Resolutions 5 and 6:

- (a) the Placement Shares were issued to professional and sophisticated investors who are clients of Peak Asset Management Pty Ltd. The recipients were identified through a bookbuild process, which involved Peak Asset Management Pty Ltd Pty Ltd seeking expressions of interest to participate in the capital raising from non-related parties of the Company. None of the recipients are related parties of the Company;
- (b) 87,680,000 Placement Shares were issued on the following basis:
  - (i) 52,603,931 Shares issued pursuant to Listing Rule 7.1 (ratification of which is sought under Resolution 5); and
  - (ii) 35,076,069 Shares issued pursuant to Listing Rule 7.1A (ratification of which is sought under Resolution 6);
- (c) the issue price was \$0.0125 per Placement Share under both the issue of Shares pursuant to Listing Rule 7.1 and Listing Rule 7.1A. The Company has not and will not receive any other consideration for the issue of the Placement Shares;
- (d) the Placement Shares issued were all fully paid ordinary shares in the capital of the Company issued on the same terms and conditions as the Company's existing Shares;
  - (i) the purpose of the issue of the Placement Shares was to raise \$1,096,000, which will be used for exploration and development on existing or future assets, general working and other capital;
  - (ii) the Placement Shares were issued under an agreement with terms and conditions similar to other agreements of a capital raising nature; and
  - (iii) a voting exclusion statement is included in Resolutions 5 and 6 of the Notice.

---

## 8. RESOLUTION 7 – APPROVAL FOR ISSUE OF OPTIONS – PLACEMENT

### 8.1 General

Resolution 7 seeks Shareholder approval for the issue of up to 93,840,005 Options for nil cash consideration to subscribers in the Placement announced on ASX on 12 August 2020 on the basis of 1 Option for every 1 Share subscribed for and issued (**Option Placement**).

The Company intends to apply for quotation of the Options the subject of this Resolution 7. The Options will only be quoted where all the requirements of ASX Listing Rule 2.5 condition 6 are met, including the requisite number of holders.

As summarised in Section 6.2 above, Listing Rule 7.1 limits the amount of equity securities that a listed company can issue without the approval of its shareholders over any 12 month period to 15% of the fully paid ordinary shares it had on issue at the start of that period. The proposed issue of the Options the subject of Resolution 7 does not fall within any of these exceptions and exceeds the 15% limit in Listing Rule 7.1. It therefore requires the approval of Shareholders under Listing Rule 7.1.

The effect of Resolution 7 will be to allow the Company to issue the Options pursuant to the Placement during the period of 3 months after the Meeting (or a

longer period, if allowed by ASX), without using the Company's 15% annual placement capacity.

## **8.2 Technical information required by Listing Rule 14.1A**

If Resolution 7 is passed, the Company will be able to proceed with the Option Placement. In addition, the issue of the Options will be excluded from the calculation of the number of equity securities that the Company can issue without Shareholder approval under Listing Rule 7.1.

If Resolution 7 is not passed, the Company will not be able to proceed with the Option Placement at this point in time and the issue of the Options would likely be made at a later date when the Company has placement capacity to do so.

Resolution 7 seeks Shareholder approval for the purposes of Listing Rule 7.1 for the Option Placement.

## **8.3 Technical information required by ASX Listing Rule 7.1**

Pursuant to and in accordance with ASX Listing Rule 7.3, the following information is provided in relation to Resolution 7:

- (a) the Options will be issued to professional and sophisticated investors who participated in the Placement and were identified as set out in Section 2.5(a). None of the participants are related parties of the Company;
- (b) the maximum number of Options to be issued is 93,840,005;
- (c) the Options will be issued no later than 3 months after the date of the Meeting (or such later date to the extent permitted by any ASX waiver or modification of the ASX Listing Rules) and it is intended that issue of the Options will occur on the same date;
- (d) the issue price of the Options will be nil as they will be issued free attaching to the Shares the subject of the Placement on a one-for-one basis;
- (e) the Options will be issued to those entities that participated in the Placement on the basis of 1 Option for every 1 Share subscribed for and issued;
- (f) the Options will be issued on the terms and conditions set out in Schedule 1 and the Company intends to apply for quotation of the Options subject to compliance with all ASX requirements; and
- (f) no funds will be raised from the Option Placement as the Options will be issued for nil cash consideration, free-attaching (on a one-for-one basis) to the Shares the subject of the Placement.

---

## **9. RESOLUTION 8 – APPROVAL FOR ISSUE OF BROKER OPTIONS – PLACEMENT**

### **9.1 General**

Resolution 8 seeks Shareholder approval for the Company to issue up to 26,000,000 Options to Peak Asset Management Pty Ltd (ACN 618 737 009) (or its nominee/s) in part consideration for Peak Asset Management acting as Corporate Adviser and Lead Manager to the Placement announced on ASX on 12 August 2020 (**Broker Options**).

As summarised in Section 6.2 above, Listing Rule 7.1 limits the amount of equity securities that a listed company can issue without the approval of its shareholders over any 12 month period to 15% of the fully paid ordinary shares it had on issue at the start of that period. The proposed issue of the Broker Options does not fall within any of these exceptions and exceeds the 15% limit in Listing Rule 7.1. It therefore requires the approval of Shareholders under Listing Rule 7.1.

## **9.2 Technical information required by ASX Listing Rule 14.1A**

If Resolution 8 is passed, the Company will be able to proceed with the issue of the Broker Options. In addition, the issue of the Broker Options will be excluded from the calculation of the number of equity securities that the Company can issue without Shareholder approval under Listing Rule 7.1.

If Resolution 8 is not passed, the Company will not be able to proceed with the issue of the Broker Options and would need to go back to Peak Asset Management to renegotiate.

Resolution 8 seeks Shareholder approval for the purposes of Listing Rule 7.1 for the issue of the Broker Options.

## **9.3 Technical information required by ASX Listing Rule 7.1**

Pursuant to and in accordance with ASX Listing Rule 7.3, the following information is provided in relation to this Resolution:

- (a) the Broker Options will be issued to Peak Asset Management (or its nominee/s), who is not a related party of the Company;
- (b) the maximum number of Broker Options to be issued is 26,000,000;
- (c) the Broker Options will be issued no later than 3 months after the date of the Meeting (or such later date to the extent permitted by any ASX waiver or modification of the ASX Listing Rules) and it is intended that the issue of the Options will occur on the same date;
- (d) the Broker Options will be issued at a nil issue price as part consideration for Peak Asset Management acting as a Corporate Adviser and Lead Manager to the Placement announced to ASX on 12 August 2020;
- (e) the purpose of the issue of the Broker Options is to satisfy the Company's obligations under the Placement Agreement;
- (f) the Broker Options are being issued to Peak Asset Management (or its nominee/s) under the Placement Agreement;
- (g) the Broker Options will be issued on the terms and conditions set out in Schedule 1 and the Company intends to apply for quotation of the Broker Options subject to compliance with all ASX requirements; and
- (h) no funds will be raised from the issue as the Broker Options are being issued in part consideration for Peak Asset Management acting as Broker to the Acquisition;
- (i) the Broker Options are not being issued under, or to fund, a reverse takeover; and
- (j) a voting exclusion statement is included in Resolution 8 of the Notice.

---

## **10. RESOLUTION 9 – APPROVAL FOR FUTURE ISSUE OF SHARES AND OPTIONS**

### **10.1 General**

Resolution 9 seeks Shareholder approval for the issue of up to 100,000,000 Shares at an issue price set out in Section 7.3(c) and up to 100,000,000 free-attaching Options (**Proposed Placement**).

The Company does not currently have a lead manager mandate in place with respect to the Proposed Placement and is not currently in negotiations with any lead managers in this regard. The Company will consider engaging a lead manager at the time the funds are to be raised. The Company anticipates that any fees payable to a lead broker will be on standard market rates of approximately 5% to 6% of the total funds raised.

As summarised in Section 6.2 above, Listing Rule 7.1 limits the amount of equity securities that a listed company can issue without the approval of its shareholders over any 12 month period to 15% of the fully paid ordinary shares it had on issue at the start of that period.

The proposed issue of the Shares and Options does not fall within any of these exceptions and may exceed the 15% limit in Listing Rule 7.1. Accordingly, the Company is seeking Shareholder approval under Listing Rule 7.1 for the Proposed Placement.

### **10.2 Technical information required by Listing Rule 14.1A**

Whilst the number of the Shares and Options may not exceed the 15% limit in Listing Rule 7.1 at the time the Proposed Placement is undertaken, the Company wishes to retain as much flexibility as possible to issue additional equity securities into the future without having to obtain Shareholder approval under Listing Rule 7.1. To do this, the Company is asking Shareholders to approve the issue of the Shares and Options under Listing Rule 7.1 so that it does not use up any of the 15% limit on issue equity securities without shareholder approval set out in Listing Rule 7.1.

If Resolution 9 is passed, the Company will be able to proceed with the issue of the Shares and Options pursuant to the Proposed Placement. In addition, the issue of the Shares and Options will be excluded from the calculation of the number of equity securities that the Company can issue without Shareholder approval under Listing Rule 7.1.

If Resolution 9 is not passed, the Company may not be able to proceed with the issue of the Shares and Options.

Resolution 9 seeks Shareholder approval for the purposes of Listing Rule 7.1 for the Proposed Placement.

### **10.3 Technical information required by ASX Listing Rule 7.1**

Pursuant to and in accordance with ASX Listing Rule 7.3, the following information is provided in relation to Resolution 9:

- (a) the maximum number of Shares to be issued is 100,000,000 and the maximum number of Options to be issued is 100,000,000;
- (b) the Shares and Options will be issued no later than 3 months after the date of the Meeting (or such later date to the extent permitted by any

ASX waiver or modification of the ASX Listing Rules) and it is intended that issue of the Shares and Options will occur on the same date;

- (c) the issue price of the Shares will be not less than 80% of the volume weighted average price for Shares calculated over the 5 days on which sales in the Shares are recorded before the day on which the issue is made or, if there is a prospectus, over the last 5 days on which sales in the securities were recorded before the date the prospectus is signed. The Company will not receive any other consideration for the issue of the Shares;
- (d) the issue price of the Options will be nil as they will be issued free-attaching to the Shares at a maximum of a one-for-one basis;
- (e) if a lead manager is appointed by the Company, the Shares and Options will be issued to professional and sophisticated investors who are clients of the lead manager. The recipients will likely be identified through a bookbuild process, which will involve the lead manager seeking expressions of interest to participate in the capital raising from non-related parties of the Company. If a lead manager is not appointed by the Company, the Shares and Options will be issued to professional and sophisticated investors who will be identified by the Directors. The recipients will be identified through the Directors seeking expressions of interest to participate in the Proposed Placement from non-related parties of the Company;
- (f) the Shares issued will be fully paid ordinary shares in the capital of the Company issued on the same terms and conditions as the Company's existing Shares;
- (g) the Options will be issued on the terms and conditions set out in Schedule 1 and the Company will apply for quotation of the Options subject to compliance with all ASX requirements;
- (h) the Company intends to use the funds raised by the Proposed Placement towards continued exploration and development at the Company's Havilah Gold Project and Tuckers Hill Gold Project both located in New South Wales, at Abenab Vanadium Project in Namibia, or for exploration expenditure on any existing or future assets acquired by the Company and general working and other capital. Additional funding is required to support the planned exploration activities on the Company's projects.
- (i) the Shares and Options are not being issued under, or to fund, a reverse takeover; and
- (j) a voting exclusion statement is included in Resolution 9 of the Notice.

#### **10.4 Dilution**

Assuming no Options are exercised, or other Shares issued, the maximum number of Shares under this Resolution are issued, the number of Shares on issue would increase from 538,440,699 (being the number of Shares on issue as at the date of this Notice) to 638,440,699 and the shareholding of existing Shareholders would be diluted by 18.57%.

If subsequently the Options issued under this Resolution are exercised (and provided no other Shares are issued or Options exercised), the number of Shares

on issue would increase from 638,440,699 to 738,440,699 , which would dilute the shareholding of existing Shareholders by an additional 18.57%.

## 10.5 Trading history

The volume weighted average price for Shares on the 5 days on which sales in Shares were recorded before 15 September 2020 was \$0.0187. The lowest issue price (i.e. maximum discount) of not less than 80% of this volume weighted average price would be \$0.01496 per Share.

If the Company issued the maximum number of Shares under this Resolution at an issue price of \$0.01496 per Share, the Company would raise \$1,496,000.

## **11. RESOLUTION 10 – APPROVAL FOR ISSUE OF OPTIONS**

### **11.1 General**

Resolution 10 seeks Shareholder approval for the Company to issue up to 80,000,000 Options to employees, consultants and service providers (or their nominee/s) of the Company.

ASX Listing Rule 7.1 provides that a company must not, subject to specified exceptions, issue or agree to issue more equity securities during any 12 month period than that amount which represents 15% of the number of fully paid ordinary securities on issue at the commencement of that 12 month period.

ASX Listing Rule 7.4 sets out an exception to ASX Listing Rule 7.1. It provides that where a company in general meeting ratifies the previous issue of securities made pursuant to ASX Listing Rule 7.1 (and provided that the previous issue did not

breach ASX Listing Rule 7.1) those securities will be deemed to have been made with shareholder approval for the purpose of ASX Listing Rule 7.1.

By ratifying this issue, the Company will retain the flexibility to issue equity securities in the future up to the 15% annual placement capacity set out in ASX Listing Rule 7.1 without the requirement to obtain prior Shareholder approval.

The effect of this Resolution will be to allow the Company to issue the Options to employees, consultants, service providers and contractors and others who have provided services to the Company (or their nominee/s) during the period of 3 months after the Meeting (or a longer period, if allowed by ASX), without using the Company's 15% annual placement capacity.

## **11.2 Technical information required by ASX Listing Rule 7.1**

Pursuant to and in accordance with ASX Listing Rule 7.3, the following information is provided in relation to this Resolution:

- (a) the maximum number of Options to be issued is 80,000,000;
- (b) the Options will be issued no later than 3 months after the date of the Meeting (or such later date to the extent permitted by any ASX waiver or modification of the ASX Listing Rules) and it is intended that the issue of the Options will occur on the same date;
- (c) the Options will be issued for 0.002 cents each to employees, consultants and service providers to participate in the equity of the Company whilst also linking the services provided to the future growth of the Company's equity securities;
- (d) the Options will be issued to employees, consultants and service providers who are not related parties of the Company. The recipients will be issued the Options at a price of 0.002 cents each, with the allocation to be made as follows;
  - (i) 64,000,000 to Kalgoorlie Mine Management Pt Ltd ("KMM") (or its nominee/s).

KMM is the counterparty to a Services Agreement entered in to with the Company, under which KMM is entitled to a service fee as remuneration for a wide range of services provided by KMM to the Company. In light of the circumstances surrounding Covid-19 and the global economic impact resulting from this pandemic, KMM reviewed the Services Agreement. KMM acknowledged that the Company had experienced negative economic consequences attributable to the economic fallout of Covid-19, and as a result, charged nil services fees for a period of three months from 1 April 2020.

In addition, under the Services Agreement, KMM is entitled to recover from the Company chargeable costs including for rental of office premises. The Company has not, nor will be, charged costs for the rental of office premises for a period of thirty months as from 1 January 2018.

Whilst no agreement was made with KMM to compensate it for the loss of income above, the Board of Directors is of the opinion that, as a result of the various measures of support provided by KMM outlined above, the Company has been able to successfully navigate a difficult financial

period in the Company's history. The Board of Directors believe that the offer of Options to KMM allows the Company to partially compensate KMM in a cost-effective manner.

- (ii) 8,000,000 to Mr Martin Stein (or his nominee/s).

Mr Stein is the Chief Financial Officer and Company Secretary of Golden Deeps Ltd. In light of the circumstances surrounding Covid-19 and the global economic impact resulting from this pandemic, Mr Stein's remuneration was reduced for a period of six months from 15 April 2020.

Whilst no agreement was made with Mr Stein to compensate him for the loss of income outlined above, the Board of Directors believe that the offer of the Options to Mr Stein allows the Company to retain the services of Mr Stein in a cost effective manner, whilst providing Mr Stein the ability to participate in the equity of the Company whilst also linking the services provided to the future growth of the Company's equity securities.

- (iii) 8,000,000 to Mr Martin Bennett (or his nominee/s).

Mr Bennett is the Exploration Manager of Golden Deeps Ltd. In light of the circumstances surrounding Covid-19 and the global economic impact resulting from this pandemic, Mr Bennett's remuneration was reduced for a period of six months from 15 April 2020.

Whilst no agreement was made with Mr Bennett to compensate him for the loss of income outlined above, the Board of Directors believe that the offer of the Options to Mr Bennett allows the Company to retain the services of Mr Bennett in a cost effective manner, whilst providing Mr Bennett the ability to participate in the equity of the Company whilst also linking the services provided to the future growth of the Company's equity securities.

- (e) the Options will be issued on the terms and conditions set out in Schedule 1 and the Company intends to apply for quotation of the Options. As at the date of this Notice of Meeting, the Options are in the money; and
- (f) \$1,600 will be raised from the issue as the Options.
- (g) the Company intends to use the funds raised by the Proposed Placement towards general working capital.

### **11.3 Technical information required by Listing Rule 14.1A**

If Resolution 10 is passed, the Options will be excluded in calculating the Company's 15% limit in Listing Rule 7.1, effectively increasing the number of equity securities the Company can issue without Shareholder approval over the 12 month period following the date of issue of the Consideration Options.

If Resolution 10 is not passed, the Options will be included in calculating the Company's 15% limit in Listing Rule 7.1, effectively decreasing the number of

equity securities that the Company can issue without Shareholder approval over the 12 month period following the date of issue of the Options.

## **12. RESOLUTION 11 – APPROVAL FOR ISSUE OF SHARES – MARKETING CONSULTANT**

### **12.1 General**

Resolution 11 seeks Shareholder approval for the Company to issue 1,250,000 Shares at \$0.016 per Share to StocksOnline Pty Ltd (ACN 616 724 559) (or its nominee/s) in consideration for StocksOnline Pty Ltd undertaking a media campaign on behalf of the Company (**Marketing Consultant Shares**).

As summarised in Section 6.2 above, Listing Rule 7.1 limits the amount of equity securities that a listed company can issue without the approval of its shareholders over any 12 month period to 15% of the fully paid ordinary shares it had on issue at the start of that period. The proposed issue of the Marketing Consultant Shares does not fall within any of these exceptions and exceeds the 15% limit in Listing Rule 7.1. It therefore requires the approval of Shareholders under Listing Rule 7.1.

### **12.2 Technical information required by ASX Listing Rule 14.1A**

If Resolution 11 is passed, the Company will be able to proceed with the issue of the Marketing Consultant Shares. In addition, the issue of the Marketing Consultant Shares will be excluded from the calculation of the number of equity securities that the Company can issue without Shareholder approval under Listing Rule 7.1.

If Resolution 11 is not passed, the Company will not be able to proceed with the issue of the Marketing Consultant Shares and would need to go back to StocksOnline Pty Ltd to renegotiate.

Resolution 11 seeks Shareholder approval for the purposes of Listing Rule 7.1 for the issue of the Marketing Consultant Shares.

### **12.3 Technical information required by ASX Listing Rule 7.1**

Pursuant to and in accordance with ASX Listing Rule 7.3, the following information is provided in relation to this Resolution:

- (a) the Marketing Consultant Shares will be issued to StocksOnline Pty Ltd (or its nominee/s), who is not a related party of the Company;
- (b) the maximum number of Marketing Consultant Shares to be issued is 1,250,000;
- (c) the Marketing Consultant Shares will be issued no later than 3 months after the date of the Meeting (or such later date to the extent permitted by any ASX waiver or modification of the ASX Listing Rules) and it is intended that the issue of the Marketing Consultant Shares will occur on the same date;
- (d) the Marketing Consultant Shares will be issued at an issue price of \$0.016 as consideration for StocksOnline Pty Ltd undertaking a media campaign on behalf of the Company;
- (e) the purpose of the issue of the Marketing Consultant Shares is to satisfy the Company's obligations under an agreement with StocksOnline Pty Ltd to undertake a media campaign on behalf of the Company. The terms of the agreement are that StocksOnline Pty Ltd is to perform a

digital media campaign to its client base to a total agreed value of \$20,000 (plus GST);

- (f) the Marketing Consultant Shares are being issued to StocksOnline Pty Ltd (or its nominee/s) under the agreement;
- (g) the Marketing Consultant Shares will be issued on the same terms and conditions as all other fully paid ordinary shares in the Company, and the Company intends to apply for quotation of the Marketing Consultant Shares subject to compliance with all ASX requirements; and
- (h) \$20,000 will be raised from the issue of the Marketing Consultant Shares;
- (i) the Marketing Consultant Shares are not being issued under, or to fund, a reverse takeover; and
- (j) a voting exclusion statement is included in Resolution 11 of the Notice.

## Instructions for completing Proxy Form

1. **(Appointing a proxy):** A Shareholder entitled to attend and cast a vote at the Meeting is entitled to appoint a proxy to attend and vote on their behalf at the Meeting. If a Shareholder is entitled to cast 2 or more votes at the Meeting, the Shareholder may appoint a second proxy to attend and vote on their behalf at the Meeting. However, where both proxies attend the Meeting, voting may only be exercised on a poll. The appointment of a second proxy must be done on a separate copy of the Proxy Form.
