The Directors have considered the matters set out in ASIC Regulatory Guide 170 and believe that they do not have a reasonable basis to forecast future earnings on the basis that the operations of the Company are inherently uncertain. Accordingly, any forecast or projection information would contain such a broad range of potential outcomes and possibilities that it is not possible to prepare a reliable best estimate forecast or projection.

Clearing House Electronic Sub-Register System (CHES) and Issuer Sponsorship

The Company will apply to participate in CHES, for those investors who have, or wish to have, a sponsoring stockbroker. Investors who do not wish to participate

through CHES will be issuer sponsored by the Company.

Electronic sub-registers mean that the Company will not be issuing certificates to investors. Instead, investors will be provided with statements (similar to a bank account statement) that set out the number of Securities issued to them under this Prospectus. The notice will also advise holders of their Holder Identification Number or Security Holder Reference Number and explain, for future reference, the sale and purchase procedures under CHES and issuer sponsorship.

Electronic sub-registers also mean ownership of securities can be transferred without having to rely upon paper documentation. Further monthly statements will be provided to holders if there have been any changes in their security holding in the Company during the preceding month.

The commencement of quotation of the New Options is subject to confirmation from the ASX. Any extension of the Closing Date of an Offer may have a consequential effect on the issue date of the respective New Options under that Offer. The Company also reserves the right not to proceed with any of the Option Offers at that time.

1.2 Background to the Option Offers

1.2.1 The Placement Options

On 6 September 2024 the Company announced that it had received firm commitments in respect of a placement to sophisticated and professional investors to raise \$1,784,750 (before costs). The participants in the Placement (**Placement Participants**) subsequently included six investors in accordance with s708(1) of the Corporations Act. On 13 September 2024, 30,250,000 Shares were issued to the Placement Participants at an issue price of \$0.059 per Share (**Placement**). The Company also agreed to issue the Placement Participants one free-attaching Option for every Share subscribed for and issued, which will result in the issue of up to 30,250,000 Options exercisable at \$0.10 each on or before 31 October 2029 (**Placement Options**).

The Placement raised \$1,784,750 (before costs) for the Company.

1.2.2 The Broker Options

PAC Partners Securities Pty Ltd (PAC) and CoPeak Pty Ltd, trading as Peak Asset Management (Peak), were engaged to act as Exclusive Joint Lead Managers (JLM) and bookrunners to the Placement pursuant to a letter of engagement (**Joint Lead Manager Mandate**).

Pursuant to the Joint Lead Manager Mandate, the Company agreed to:

- (a) pay the JLM a commission 6% of the total funds raised under the Placement plus GST; and
- (b) upon successful completion of the Placement and to subject Shareholder approval, issue the JLM (or their nominee/s) 14,000,000 Options with an

exercise price of \$0.10 and expiry date of 31 October 2029 (**Broker Options**).

The issue of the Broker Options was subject to \$1,780,000 being raised by the Placement. The JLM successfully met this condition by raising \$1,784,750.

1.2.3 General Meeting

The Company agreed to seek shareholder approval to issue the Placement Options and Broker Options (**Option Offers**), and to list the Option Offers subject to meeting the ASX's minimum quotation requirements.

At the General Meeting held on 18 October 2024 the Company obtained shareholder approval, amongst other things, to:

- (a) issue 30,250,000 Placement Options exercisable at \$0.10 on or before 31 October 2024 to the Placement Participants (as noted in Section 1.2.1 the Company issued 30,250,000 Shares under the Placement); and
- (b) issue 14,000,000 Broker Options exercisable at \$0.10 on or before 31 October 2029 to the JLM.

Further details in respect of the Placement and these proposed security issues is set out in the notice of meeting released on 18 September 2024.

The Placement Options and Broker Options are being offered pursuant to this Prospectus.

1.2.4 Use of Funds

The funds raised under the Placement are intended to be applied as set out in the table below.

2. DETAILS OF THE OPTION OFFERS

2.1 The Option Offers

2.1.1 Placement Options

The Placement Options is an offer of one Option for each Share subscribed for and issued under the Placement. 30,250,000 Shares were issued under the Placement, and up to 30,250,000 free attaching Placement Options will be issued under the Placement Offer. No funds will be raised from the issue of the Placement Options.

The Placement Options will be exercisable at \$0.10 each on or before 31 October 2029 and otherwise issued on the terms and conditions set out in Section 4.1.

Shareholders approved the issue of the Placement Options at the General Meeting held on 18 October 2024.

The Placement Options will be listed on the ASX subject to the ASX's minimum quotation requirements.

Shares issued upon exercise of the Options offered under this Prospectus will rank equally with the Shares on issue at the date of this Prospectus. Please refer to Section 4.2 for further information regarding the rights and liabilities attaching to the Shares.

2.1.2 Broker Options

The Broker Options is an offer of up to 14,000,000 Options to the JLM for the successful completion of the Placement to raise \$1,784,750 (before costs).

The Broker Options will be exercisable at \$0.10 each on or before 31 October 2029 and otherwise issued on the terms and conditions set out in Section 4.1.

Shareholders approved the issue of the Broker Options at the General Meeting held on 18 October 2024.

The Broker Options will be listed on the ASX subject to the ASX's minimum quotation requirements.

Shares issued upon exercise of the Broker Options offered under this Prospectus will rank equally with the Shares on issue at the date of this Prospectus. Please refer to Section 4.2 for further information regarding the rights and liabilities attaching to the Shares.

2.2 Lead Manager

There is no lead manager to the Option Offers.

The JLM were acting as joint lead manager and bookrunners to the Placement and were paid a commission 6% of the funds raised under the Placement. In addition, shareholders have approved the issue to the JLM (or their nominees) 14,000,000 Broker Options. The Broker Options will be exercisable at \$0.10 each on or before 31 October 2029.

2.3 Application for Option Offers

2.3.1 Placement Options

The Placement Options will only be extended to the Placement Participants. Application Forms will only be provided to these participants on invitation by the Directors. Applicants under the Placement Options must lodge their Application Form as directed.

No payment is required to subscribe for the Placement Options.

The Company reserves all discretions in relation to applications for the Placement Options.

2.3.2 Broker Options

The Broker Options will only be extended to the JLM (or their nominees). Application Forms will only be provided to these participants on invitation by the Directors. Applicants under the Broker Options must lodge their Application Form as directed.

No payment is required to subscribe for the Broker Options.

The Company reserves all discretions in relation to applications for the Broker Options.

2.4 Implications of an acceptance

By completing an Application Form, Applicants will be taken to have declared that all details and statements made by them are complete and accurate and that they have personally received the Application Form together with a complete and unaltered copy of the Prospectus.

Completed Application Forms must be mailed or delivered to the address set out on the Application Form, with sufficient time to be received by or on behalf of the Company by no later than 5.00pm (WST) on the Closing Date, which is currently scheduled to occur on 27 November 2024.

2.5 Defects in Application Forms

If an Application Form is not completed correctly, the Company may, in its sole discretions, still treat the Application Form to be valid. The Company's decisions to treat an application as valid, or how to construe, amend or complete it, will be final.

2.6 ASX listing

Application for Official Quotation of the Options offered pursuant to this Prospectus will be made within seven days of the date of the Prospectus. If ASX does not grant Official Quotation of the New Options before the expiration of three months after the date of this Prospectus, or such period as varied by the ASIC, the Company will not issue any New Options.

No application moneys will be repayable if the New Options are not issued within the time period given that the New Options are being issued for nil consideration.

The fact that the ASX may grant Official Quotation of the New Options is not to be taken in any way as an indication of the merits of the Company or the New Options offered for subscription under this Prospectus.

2.7 Issue

Securities issued pursuant to the Option Offers will be issued in accordance with the ASX Listing Rules and timetable set out at Section 1.1.

Holding statements for Securities issued under the Option Offers will be mailed as soon as practicable after the issue of Securities.

2.8 Overseas shareholders

These Option Offers do not, and are not intended to, constitute offers in any place or jurisdiction in which, or to any person to whom, would not be lawful to make such offers or to issue this Prospectus.

It is not practicable for the Company to comply with the securities laws of overseas jurisdictions having regard to the number of overseas Shareholders, the number and value of Securities these Shareholders would be offered and the cost of complying with regulatory requirements in each relevant jurisdiction. Accordingly, the Option Offers are not being extended and Securities will not be issued to investors with a registered address which is outside Australia.

2.9 Minimum Subscriptions

There is no minimum subscriptions to the Option Offers.

3. PURPOSE AND EFFECT OF THE OPTION OFFERS

3.1 Purpose of the Option Offers

The Option Offers are being made such that the relief provided under ASIC Corporations (Sale Offers That Do Not Need Disclosure) Instrument 2016/80 with respect to the on-sale provisions of section 707 of the Corporations Act is available.

Specifically, if the New Options are issued with disclosure under this Prospectus, then the Shares issued upon the exercise of any of the Options can be on-sold within 12 months of their issue, without a disclosure document for the on-sale offer.

No funds will be raised under the Option Offers (other than the funds raised if the New Options are subsequently exercised) as the Placement Options are being issued on the basis of one Option for every Share subscribed for and issued under the Placement, and the Broker Options are being issued for services provided by the JLM under the Placement.

3.2 Effect of the Placement and the Option Offers

The principal effect of the Option Offers (assuming that that all New Options are issued and no other Securities are issued or exercised or converted) will be to:

- (a) increase the number of Options on issue from nil as at the date of this Prospectus to 44,250,000 Options;
- (b) subject to ASX granting Official Quotation of the Option Offers, holders will be able to trade the Option Offers on the ASX; and
- (c) remove any trading restrictions attaching to Shares issued on exercise of the New Options issued under this Prospectus.

3.3 Effect on capital structure

The effect of the Option Offers on the capital structure of the Company, assuming all Options Offers offered under the Prospectus are issued, is set out below.

The capital structure on a fully diluted basis as at the date of this Prospectus would be 151,522,349 Shares and on completion of the Option Offers (assuming all Options offered under this Prospectus are issued) would be 195,772,349 Shares.

3.4 Financial effects of the Offers

The New Options to be issued pursuant to the Option Offers will be issued at nil issue price, accordingly there will be no immediate effect on the Company's balance sheet. However, capital will be raised if the Option Offers are exercised, which will affect the Company's balance sheet.

The Company is unable to specify with any certainty the extent of any change to the balance sheet, given that there is no certainty if or when any of the Option Offers will be exercised.

The expenses of the Option Offers will be met from the Company's existing cash reserves.

As a result, the Option Offers will have an effect on the Company's financial position, being the decrease in the Company's existing cash reserves.

3.5 Details of substantial holders

Based on publicly available information as at the date of this Prospectus, the holders who (together with their associates) have a relevant interest in 5% or more of the Shares on issue are Coniston Pty Ltd and Kalgoorlie Mine Management Pty Ltd (ABN 57 009 235 625), which collectively hold 7,921,400 Shares, being 5.23% of the Shares on issue at the date of this Prospectus.

4. RIGHTS AND LIABILITIES ATTACHING TO SECURITIES

4.1 Placement Options and Broker Options

(a) **Entitlement**

Each New Option entitles the holder to subscribe for one Share upon exercise of the Option.

(b) **Exercise Price**

Subject to paragraph (i), the amount payable upon exercise of each Option will be \$0.10 (**Exercise Price**).

(c) **Expiry Date**

Each New Option will expire at 5:00 pm (WST) on 31 October 2029 (**Expiry Date**). An Option not exercised before the Expiry Date will automatically lapse on the Expiry Date.

(d) **Exercise Period**

The New Options are exercisable at any time on or prior to the Expiry Date (**Exercise Period**).

(e) **Notice of Exercise**

The New Options may be exercised during the Exercise Period by notice in writing to the Company in the manner specified on the Option certificate (**Notice of Exercise**) and payment of the Exercise Price for each Option being exercised in Australian currency by electronic funds transfer or other means of payment acceptable to the Company.

(f) **Exercise Date**

A Notice of Exercise is only effective on and from the later of the date of receipt of the Notice of Exercise and the date of receipt of the payment of the Exercise Price for each Option being exercised in cleared funds (**Exercise Date**).

(g) **Timing of issue of Shares on exercise**

Within 15 Business Days after the Exercise Date, the Company will:

- (i) issue the number of Shares required under these terms and conditions in respect of the number of Options specified in the Notice of Exercise and for which cleared funds have been received by the Company;
- (ii) if required, give ASX a notice that complies with section 708A(5)(e) of the Corporations Act, or, if the Company is unable to issue such a notice, lodge with ASIC a prospectus prepared in accordance with the Corporations Act and do all such things necessary to satisfy section 708A(11) of the Corporations Act to ensure that an offer for sale of the Shares does not require disclosure to investors; and
- (iii) if admitted to the official list of ASX at the time, apply for official quotation on ASX of Shares issued pursuant to the exercise of the Options.

If a notice delivered under Section 4.2(g)(ii) for any reason is not effective to ensure that an offer for sale of the Shares does not require disclosure to investors, the Company must, no later than 20 Business Days after becoming aware of such notice being ineffective, lodge with ASIC a prospectus prepared in accordance with the Corporations Act and do all such things necessary to satisfy section 708A(11) of the Corporations Act to ensure that an offer for sale of the Shares does not require disclosure to investors.

(h) **Shares issued on exercise**

Shares issued on exercise of the Options rank equally with the then issued shares of the Company.

(i) **Reconstruction of capital**

If at any time the issued capital of the Company is reconstructed, all rights of an Optionholder are to be changed in a manner consistent with the Corporations Act and the ASX Listing Rules at the time of the reconstruction.

(j) **Participation in new issues**

There are no participation rights or entitlements inherent in the Options and holders will not be entitled to participate in new issues of capital offered to Shareholders during the currency of the Options without exercising the Options.

(k) **Change in exercise price**

An Option does not confer the right to a change in Exercise Price or a change in the number of underlying securities over which the Option can be exercised.

(l) **Transferability**

The Options are transferable subject to any restriction or escrow arrangements imposed by ASX or under applicable Australian securities laws.

4.2 Shares

The following is a summary of the more significant rights and liabilities attaching to the Shares being offered pursuant to this Prospectus. This summary is not exhaustive and does not constitute a definitive statement of the rights and liabilities of Shareholders. To obtain such a statement, persons should seek independent legal advice.

Full details of the rights and liabilities attaching to Shares are set out in the Constitution, a copy of which is available for inspection at the Company's registered office during normal business hours.

(a) **General meetings**

Shareholders are entitled to be present in person, or by proxy, attorney or representative to attend and vote at general meetings of the Company.

Shareholders may requisition meetings in accordance with section 249D of the Corporations Act and the Constitution of the Company.

(b) **Voting rights**

Subject to any rights or restrictions for the time being attached to any class or classes of shares, at general meetings of shareholders or classes of shareholders:

- (i) each Shareholder entitled to vote may vote in person or by proxy, attorney or representative;
- (ii) on a show of hands, every person present who is a Shareholder or a proxy, attorney or representative of a Shareholder has one vote; and
- (iii) on a poll, every person present who is a Shareholder or a proxy, attorney or representative of a Shareholder shall, in respect of each fully paid Share held by him, or in respect of which he is appointed a proxy, attorney or representative, have one vote for each Share held, but in respect of partly paid shares shall have such number of votes as bears the same proportion to the total of such Shares registered in the Shareholder's name as the amount paid (not credited) bears to the total amounts paid and payable (excluding amounts credited).

(c) **Dividend rights**

Subject to the rights of any preference Shareholders and to the rights of the holders of any shares created or raised under any special arrangement as to dividend, the Directors may from time to time declare a dividend to be paid to the Shareholders entitled to the dividend which shall be payable on all Shares according to the proportion that the amount paid (not credited) is of the total amounts paid and payable (excluding amounts credited) in respect of such Shares.

The Directors may from time to time pay to the Shareholders any interim dividends as they may determine. No dividend shall carry interest as against the Company. The Directors may set aside out of the profits of the Company any amounts that they may determine as reserves, to be applied at the discretion of the Directors, for any purpose for which the profits of the Company may be properly applied.

Subject to the ASX Listing Rules and the Corporations Act, the Company may, by resolution of the Directors, implement a dividend reinvestment plan on such terms and conditions as the Directors think fit and which provides for any dividend which the Directors may declare from time to time payable on Shares which are participating Shares in the dividend reinvestment plan, less any amount which the Company shall either pursuant to the Constitution or any law be entitled or obliged to retain, be applied by the Company to the payment of the subscription price of Shares.

(d) **Winding-up**

If the Company is wound up, the liquidator may, with the authority of a special resolution, divide among the Shareholders in kind the whole or any part of the property of the Company, and may for that purpose set such value as he considers fair upon any property to be so divided, and may determine how the division is to be carried out as between the Shareholders or different classes of Shareholders.

The liquidator may, with the authority of a special resolution, vest the whole or any part of any such property in trustees upon such trusts for the benefit of the contributories as the liquidator thinks fit, but so that no Shareholder is compelled to accept any shares or other securities in respect of which there is any liability.

(e) **Shareholder liability**

As the Shares issued will be fully paid shares, they will not be subject to any calls for money by the Directors and will therefore not become liable for forfeiture.

(f) **Transfer of shares**

Generally, shares in the Company are freely transferable, subject to formal requirements, the registration of the transfer not resulting in a contravention of or failure to observe the provisions of a law of Australia and the transfer not being in breach of the Corporations Act and the ASX Listing Rules.

(g) **Future increase in capital**

The issue of any new Shares is under the control of the Directors of the Company. Subject to restrictions on the issue or grant of securities contained in the ASX Listing Rules, the Constitution and the Corporations Act (and without affecting any special right previously conferred on the holder of an existing share or class of shares), the Directors may issue Shares as they shall, in their absolute discretion, determine.

(h) **Variation of rights**

Under section 246B of the Corporations Act, the Company may, with the sanction of a special resolution passed at a meeting of Shareholders vary or abrogate the rights attaching to Shares.

If at any time the share capital is divided into different classes of shares, the rights attached to any class (unless otherwise provided by the terms of issue of the shares of that class), whether or not the Company is being wound up, may be varied or abrogated with the consent in writing of the holders of three quarters of the issued shares of that class, or if authorised by a special resolution passed at a separate meeting of the holders of the shares of that class.

(i) **Alteration of constitution**

In accordance with the Corporations Act, the Constitution can only be amended by a special resolution passed by at least three quarters of Shareholders present and voting at the general meeting. In addition, at least 28 days written notice specifying the intention to propose the resolution as a special resolution must be given.
